## REGULATIONS

## MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE MINISTER OF WORKS AND TRANS-PORT UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT CHAP 48:50.

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (ST. JAMES, BELMONT AND PORT OF SPAIN) REGULATIONS, 2019

Citation	1.	These Regulations may be cited as the Traffic Control (Experimental Scheme) (St. James and Port of Spain) Regulations, 2019.
Duration	2.	These Regulations shall commence on 9th September, 2019 and expire on the 8th December, 2019.
One-way traffic	3.	<ul> <li>A person driving a motor vehicle shall proceed in a-</li> <li>a. Westerly direction only on Meyler Street, between Belmont Circular Road East and Pelham Street;</li> <li>b. Southerly direction only on Pelham Street, between Belmont Circular Road North and Clifford Street; and,</li> <li>c. Easterly direction only on St Margaret's Lane, between Belmont Circular Road East and Pelham Street.</li> <li>d. Westerly direction only on Cadiz Road, between Archer Street and Queen's Park Savannah between the hours of 6:00AM- 6:00PM Mon-Fri except public holidays.</li> </ul>
No Entry	4.	A person driving a motor vehicle shall not enter Finland Street from Vidale Street.
No Plying for Hire	5.	<ul> <li>A person driving a motor vehicle with exception of Taxi Drives operating in a taxi stand may not ply for hire his vehicle on-</li> <li>a. Independence Square North and Independence Square South</li> <li>b. South Quay, Port of Spain</li> <li>c. Abercromby Street, between South Quay and Independence Square South, Port of Spain.</li> <li>d. Queen Street, between Frederick Street and St. Vincent Street Port of Spain.</li> </ul>
Parking prohibited	6.	A person driving a motor vehicle shall not park on the northern side of Finland Street, between Ethel Street and Vidale Street.
	7.	A person driving a motor vehicle shall not park on the western side of Clarence Street, St. James.
	8.	<ul> <li>A person driving a motor vehicle shall not park on de Verteuil Street, between Warren Street and Ariapita Avenue on the—</li> <li>a. Eastern side – Monday, Wednesday, Friday; and</li> <li>b. Western side – Tuesday, Thursday, Saturday</li> </ul>
	9.	A person driving a motor vehicle shall not park on the Northern Side of Cadiz Road, Belmont between Archer Street and Queens Park Savannah during the hours of 6:00AM-6:00PM Mon-Fri except on public holidays.
	10.	A person driving a motor vehicle shall not park on the southern side of Queen Street, between Frederick Street and St. Vincent Street;
	11.	A person driving a motor vehicle shall not park a motor vehicle, trailer or place a container on Queen Street, between St Vincent Street and Richmond Street, Monday to Fridays from 6:00AM -6:00PM except on public holidays;
	12.	A person driving a motor vehicle shall not park on Independence Square North and South between the hours of 6:00AM–9:00AM; and 3:00PM-6:00PM, Monday – Fridays except on public holidays;
	13.	A person driving a motor vehicle shall not park on Knox Street, between Abercromby Street and Pembroke Street.
	14.	<ul> <li>A person driving a motor vehicle shall not park on Alberto Street:-</li> <li>a. Eastern side – Tuesday, Thursday, Saturday</li> <li>b. Western side – Monday, Wednesday, Friday;</li> </ul>
No right turn	15.	A person driving a motor vehicle shall not turn right from Belle Smythe Street to Warren Street, Woodbrook, between the hours of 6:00 a.m. to 6:00 p.m., Monday to Friday, except on public holidays.
Offence and penalty	16.	A person who contravenes these Regulations is liable on summary conviction for a first offence, to a fine of seven hundred and fifty dollars and on any subsequent convictions, to a fine of one thousand dollars.
Removal and impounding of vehicles unlawfully parked	17.	Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Regulation, may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
