Project Overview

The Government of the Republic of Trinidad and Tobago (GORTT), through the Ministry of Works and Transport (MOWT) has proposed the construction of an Offshore Fishing Port at Gran Chemin, Moruga on the south coast of Trinidad. This Offshore Fishing Port will work in tandem and offer support to the Onshore Fishing Facility which is currently being constructed under a separate CEC. To this day, fishing remains a vibrant economic activity in Moruga. However, the existing fishing facilities at Gran Chemin have deteriorated and presently in a state of disrepair. The Offshore Fishing Port has the following objectives:

- To create a modern, functional fishing facility which satisfies the demands of the fishing industry in Moruga. The current facility is practically non functional and very dilapidated.
- To create a facility for the Trinidad and Tobago Coast Guard at Gran Chemin, Moruga.
- To encourage economic development in Moruga which will provide tangible benefits to the residents of Moruga.










Project Location and Site plan of Offshore Fishing Port at Gran Chemin, Moruga
