The Ministry of Works and Transport wishes to inform the general public that *Phase Two - Reopening of all Licensing Offices commenced on Friday 23rd July, 2021 with a limited appointment system still in effect.* This is necessary to ensure that all COVID-19 health protocols, inclusive of adequate social distancing and crowd control are maintained at all Licensing Office sites.

During Phase Two, *Inspection of Vehicles and Application for Provisional Permits have been added* to the list of services offered. See table below for list of effective dates:

- Customers will only be served at their scheduled appointment time.
- *All appointments prior to Monday 12th July 2021 are considered null and void. Customers with previous appointments are required to make new online bookings.*

Service at all Licensing Offices will continue within normal working hours (Monday - Friday, 8:00 am to 4:00 pm); however, the Officer in charge reserves the right to implement measures where necessary to mitigate congestion.
