Tenders must be accompanied by the following:-

(a) **Valid** Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. (applicable to local firms only)

(b) **Valid** Certificate of Compliance issued in accordance with the National Insurance Act. (applicable to local firms only)

The original and five (5) copies of the tender should be placed in sealed envelopes clearly marked on the outside:

Tenders will be opened shortly thereafter. The opening of the tenders will be streamed live via Zoom and Tenderers shall be provided with a link that will connect them to the live proceedings.

Tenderers should note that the dimensions of the **SLOT** of the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Late tenders **WILL NOT** be considered in any circumstances. The Board does not bind itself to accept the lowest or any other tender. The Central Tenders Board reserves the right to cancel the tendering process in its entirety or even partially, without defraying any cost incurred by any firm in submitting their tender.
