## NOTICE BY THE LICENSING AUTHORITY IN ACCORDANCE WITH SECTION 83(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC (AMENDMENT) ACT, 2017 (ACT NO. 9 OF 2017).

This is an official Public Notice by the Licensing Authority in respect of **Fixed Penalty Notices** (**Traffic Tickets**) issued on **November 30, 2023** and **December 1, 2023**.
